### May 2020 Election Notice (H.B. 305)

The Texas State Legislature passed <u>House Bill 305</u> on June 14, 2019 and becomes effective on September 1, 2019. The bill requires that a political subdivision, with the authority to impose a tax that at any time on or after January 1, 2019, maintained a publicly accessible Internet website, shall include certain information, including information regarding upcoming elections, on that website pursuant to the effective date.

#### REQUIREMENTS FOR FILING FOR CANDIDACY:

#### Filing for Office

- (A) Any qualified citizen who desires to become a candidate for the City office shall file with the City Secretary a signed application for his or her name to appear on the ballot. This application must be filed in accordance with the laws of the State of Texas.
- (B) In addition to all general requirements for application for a place on the ballot as specified in the Texas Election Code, or any other requirements specified in the laws or Constitution of the State of Texas, a candidate must possess the following qualifications:
  - (1) be a qualified voter of the City;
  - (2) reside within the corporate limits of the City; and,
  - (3) shall be a resident of the City for a period of one (1) year.
- (C) Any City employee or officer announcing their candidacy, or who in fact becomes a candidate for an elected City office, must resign from said employment or position immediately.

#### **ORDINANCE NUMBER 2020-04**

#### **BE IT ORDAINED:**

Section 1: A proclamation suspending Sections 41.0052(a) and (b) of the Texas Election Code to the extent necessary to allow political subdivisions that would otherwise hold elections on May 2, 2020, to move the general election for 2020 only to the next uniform election date, occurring on November 3, 2020, without otherwise adjusting the term of office, and suspending Sections 31.093 and 42.0621(c) of the Texas Election Code to the extent necessary to require all county election officers, if requested by an affected political subdivision, to enter into a contract to furnish election services with any political subdivision who postponed their election to November 3, 2020, under the authority of this proclamation.

**Section 2:** The candidate filings for the election will remain valid for the election held on the November 3, 2020 and the filing period will not be re-opened for the November 3, 2020 election.

**Section 3:** All voter ABBMs voting by mail due to being over the age of 65 or due to disability will still be valid for the postponed election and that ABBMs for voter who submitted ABBMs based on expected absence from the County would not be valid for the postponed election.

**Section 4:** The major relevant dates for the November 3, 2020 election, including the voter registration deadline (October 5, 2020), the deadline to submit an ABBM (October 23, 2020) and the dates for early voting (October 19, 2020 – October 30, 2020).

Section 5: <u>Early voting ballot application</u>. The address where an application for an early voting ballot by mail shall be mailed to:

Unless a different location is designated by the Hidalgo County Elections Department under the election services contract between Hidalgo County Elections Department and the City of Hidalgo, Texas, executed in accordance with the provisions of Texas Election Code §31.0925.

Section 6: <u>Early Voting Clerk</u>. The Early Voting Clerk shall be designated by the Hidalgo County Elections Department under an election service contract

between the Hidalgo County Elections Department and the City of Hidalgo, Texas executed in accordance with the provisions of Texas Election Code §31.0925.
